7. Each Bidder shall submit only one bid, either individually or as a partner in a joint venture. The maximum number of joint venture partners is limited to three.

Sealed Quotation documents must be valid for a period of **45 days** after bid opening and must be accompanied by Bid Security of **NRs.42,000** which shall be valid for **30 days** after the bid validity period.
